Your privacy is important to QRContact.org. ("QR Contact"). As a result, we've developed this Privacy Policy that covers how we collect, use, disclose, transfer, and store your information as it relates to your use of the https://qrcontact.org website (the "Site"). Please take a moment to familiarize yourself with our privacy practices and let us know if you have any questions.

A. Introduction

QR Contact makes reasonable efforts to protect the privacy of your personal information. This Privacy Policy was created to demonstrate our commitment to fair information practices. This Privacy Policy covers QR Contact use of personal information that we collect in the normal course of our business, when you visit our website located at <u>https://qrcontact.org (the</u> "Site"), and when you otherwise interact with us, including when you attend events hosted or attended by QR Contact and when you contact us for customer support.

In addition to covering how we collect, use, disclose, transfer, and store your information, this policy also addresses the lawful bases we may rely on to legally process your information, and your related rights. In most cases, the lawful basis will be that the processing: (i) is necessary for our legitimate interests in carrying out our business, including direct marketing, provided those interests are not outweighed by your rights and interests, or (ii) is necessary to perform a contract with you. Where processing is based on your consent, we will identify the processing purposes and provide you with relevant information at the time we get your consent to make the processing fair and transparent.

Our Site is not intended for anyone under the age of 13, and QR Contact does not knowingly solicit or collect information from anyone under 13 years of age. If you are a parent or guardian and believe we may have collected information about your child, please contact at support@qrcontact.org.

QR Contact may update this Privacy Policy from time to time. In the event we make any material changes to this Privacy Policy, we will notify you by email and by posting the revised Privacy Policy on the Site. When we update this Privacy Policy we will note the date of its most recent revision below. Any revisions will become effective (7) calendar days following the posting on the Site. If you do not agree with the terms of this Privacy Policy or any changes to the terms, you may not access our Site or use any of our services.

B. Collection of Personal Information

Depending on the context in which you interact with us, QR Contact may collect or receive the following Personal Information:

- When you request information or to be contacted, or subscribe to email on one of our Sites, we may collect your name, email address, state, or country.
- When you attend one of our events, speak with sales representatives, or when you contact customer support, we may collect your name, email, phone number, and company name.
- When you correspond with us via email, we may collect the Personal Information included in your email.
- We may receive Personal Information from third party business partners such as the contact details of prospects and sales leads.
- When you provide your information to us directly by completing forms on our website: For example, your name, contact, and address information, and any other information you may provide in the forms on our website;
- When you visit our Site or use any of our services, we may collect certain information about your device, such as your IP address, the type of device or browser you used, and your actions on our Site and services.

C. Use of Collected Personal Information

We may use the Personal Information we collect or receive for the following purposes:

- To carry out the purpose for which it was originally collected or received.
- To provide, operate, maintain and improve our products and services.
- To respond to your inquiries and provide support.
- To process and complete transactions, and send you related information.
- To market and sell our products and services. If we do so, we will provide you with a way to opt-out of receiving such communications in the future.
- To support security and authentication features on our website.
- To monitor and analyze trends, usage, and activity in connection with our products and services, and for marketing or advertising purposes.
- To customize your experience on the Site and display content that we think you
 might be interested in according to your preferences.

D. Do Not Track Signals

The Site does not respond to Do Not Track signals.

E. Sharing of Personal Information

From time to time, QR Contact may engage third party business partners or vendors to perform functions such as sending postal mail and e-mail, removing repetitive information from customer lists, analyzing data, providing marketing assistance, to market their services to you, data storage, providing search results and links (including paid listings and links), processing credit card payments, and providing customer service. Such companies shall only use your Personal Information for the limited purposes for which we shared the Personal Information with them. Additionally, QR Contact may share your Personal Information in the event of any investment, reorganization, merger, sale, joint venture, or transfer of assets. When Personal Information is shared, QR Contact will ascertain that any third parties are obligated to provide at least the same level of privacy protection as is required under this policy. Should QR Contact transfer Personal Information outside of a local jurisdiction, it shall only be done with adequate protections in place and in compliance with applicable laws and standards.

QR Contact may also share your Personal Information if we have a good faith belief that such action is necessary to: (i) protect and defend the rights or property of QR Contact; (ii) enforce this Privacy Policy or the Site's terms and conditions of access and use agreement; (iii) participate in dispute resolution pursuant to this Privacy Policy; (iv) protect the interests of other users of the Site or any other person; or (v) operate or conduct maintenance and repair of the Site or equipment. QR Contact may be required to disclose an individual's personal information in response to a lawful request by public authorities, including to meet national security or law enforcement requirements.

F. Protection of Personal Information

Taking into account the risks involved in the processing and nature of Personal Information and to prevent loss, misuse, unauthorized access, disclosure, alteration and destruction and while maintaining data accuracy, QR Contact has put in place appropriate physical, electronic, and managerial policies and procedures to safeguard the Personal Information QR Contact collects. Although we do our best to protect the Personal Information, we cannot and do not guarantee the security of your Personal Information.

G. Retention

QR Contact will retain your Personal Information for only as long as it serves the purposes for which it was collected and will be retained in a form identifying or making identifiable only for as long as it serves a purpose of processing.

H. Other Limits to Your Privacy

The Site may contain links to other non-QR Contact websites. QR Contact is not responsible for the privacy practices or the content of such websites. QR Contact has no control over the use of such websites and you should exercise caution when deciding to disclose any Personal Information on these websites.

I. Choice

We seek to provide you with choices regarding the Personal Information you provide to us. You can always opt not to disclose information. However, if you elect to do so, this may impact functionality or prevent the use of QR Contact' products or services. You have the right, at any time, to opt-out of receiving marketing messages from QR Contact by sending an email to admin@qrcontact.org or by unsubscribing through the manage subscription link in an email. We will try to comply with your request(s) as soon as reasonably practicable. Please note that if you opt-out of receiving marketing-related emails from us, we may still send you important operational or administrative messages.

J. Personal Information Requests – California and European Union Residents

If you reside in California, the European Union, or select other locations, you may be afforded certain rights regarding your personal information. Except where an exception or exemption applies, these rights may include the ability to request disclosure of the information we have collected about you (a "Personal Information Request"), the right to request deletion of your personal information, the right to review our data collection practices related to you, and the right not to be discriminated against due to your exercise of any of the preceding rights.

You may access your information that QR Contact holds or submit a Personal Information Request by contacting us at support@qrcontact.org. In certain circumstances you may request to correct, amend, or delete that information where it is inaccurate, although under certain circumstances we may decline your request, such as where the rights of other people would be violated.

To protect your privacy and security, QR Contact may also take reasonable steps to verify your identity before making corrections to, providing access to, or deleting your account.

K. Class Action Waiver

M. COOKIE POLICY

Like most websites and applications, QR Contact and our third-party partners use cookies and similar technologies to make our website and applications work, and to learn more about our users and their likely interests as well as information relating to their visits and interactions with a website or application. A cookie is a small text file placed on your device's hard drive by a web server. QR Contact may place one or more cookies or other similar technologies on your computer. QR Contact uses cookies and similar technologies to customize your interaction with our Site, to assist you with your session on our Site, and to help us maintain and improve our Site. Some QR Contact pages use cookies that permit select third party partners to serve you QR Contact-related content, including QR Contact advertisements, on their websites or elsewhere on the Internet based in part on your use of our Site.
